## **End of Year**

I am still finalising the 2022 audit and as of the date of writing cannot produce a financial statement. I hope to provide an update before our meeting. I will still be in Perth visiting my daughter so will only be able to dial in 7:30pm to 8:30pm Sydney time.

I expect a better profit than forecast last month due to lower affilation fees paid to ACA. This is because ACA affiliation fees were \$31 rather than the forecast \$32.

### **Tournament Entries**
