## Information for CNSW Members following the Meeting of the Board on Sunday 10<sup>th</sup> December 2017

In attendance John Eddes (JE), Brenda Wild (BW), Steve Thornton (ST) and Roberta Flint (RF). Due to the resignation of Nerida Taylor (NT), the Chair for the meeting was taken by BW who declared a quorum. The meeting commenced at 8:47am. Adoption of the minutes of the meeting held on 14<sup>th</sup> November 2017 was moved by JE and Seconded by BW. Carried.

Items of interest for CNSW Members that were noted/discussed/agreed to during the meeting were:

- Barb Piggott informed the board of her resignation of from ACSC. CNSW is hopeful that Barb can be persuaded to reverse this decision.
- Noted that Tricia Vierra has resigned as a Director as she is returning to Tasmania.
- Noted that Nerida Taylor has resigned as Chair of the Board and as a Director for personal reasons.
  Nerida has agreed to remain involved in a number of initiatives she commenced, being the Player Pathway, Tempe Working Group and locating a Complaints Manager.
- Treasurer advised that a new account is to be established (CNSW No2AC) for day to day use. It was agreed that the Treasurer and Secretary would be the single signatories for this account. Account to have a limit of \$5000 with a single transaction no greater than \$1000.
- Instruction given to Treasurer to have the 2016-17 accounts audited as per agreement at the AGM and intention of the constitution.
- Need for formal Confidentiality Agreement for Directors was further discussed. ST and RF to consider how this is best done so that board confidentiality is achieved and maintained.
- Discussed and agreed that Regional Organisation should be expanded to include positions such as MPIO's.
- The Tournament Committee to be given a Board directive to progress to a more forward looking event calendar (up to 3 years), and to critically review the non-championship events.
- Discussion on holding a meeting with Regional coordinators and office holders in March 2018 noting a need for some connection with the membership base.

Members may be interested to know how some matters are dealt with once they have been considered as an agenda item. If they are not confidential and are likely to be considered over a number of meetings they are moved to `a list of Discussion Items'. This list was created in September 2016, it is reviewed at each meeting and items are either kept `open' or are `closed' and a small number are `parked' for the time being. The list from this meeting is attached.
