#### 6. Chair's Report

- 6.1 **Grant funding:** Following the Sport and Recreation Support Fund grant acquittal deadline being imposed as the end of December, an updated expenditure proposal was sent to NSW Office of Sport, and the deadline has been extended until end January.
  - i) Club Hubs' 2-year funding has been expended.

- ii) The new website and database and Membership Promotion and Marketing will not be expended, and a further request to move the deadline until the end of June or April has been submitted. We are awaiting the results.
- 6.1.1 The Board agreed with the spending priorities listed, with the addition of the Gateball funding proposal.
- 6.1.2 If the deadline is not extended, the Board recommended the distribution of funds to the Clubs for new mallets as coaching resources.

**ACA Database:** Jim Nicholls has advised that a round table discussion Zoom meeting is proposed for the week commencing 16 January 2023 with all States to discuss the rollout. NSW data has been supplied but the final upload will happen prior to NSW going online.
